**Noon to 1:30 pm (lunch program) -- Elizabeth Loewy, Assistant District Attorney, Attorney in Charge/Elder Abuse Unit, NY County District Attorney’s Office.** *“The Brooke Astor Trial, a Cautionary Tale”*. Brooke Astor was the beloved doyenne of New York society who died in 2007 at the age of 105. Two years later, in a scandal that rocked New York City, both her son and estate planning attorney were convicted and sentenced to jail with respect to their part in Mrs. Astor’s care, and estate and financial planning. Ms. Loewy, one of the prosecutors who tried the case, will talk about that trial and other criminal cases involving elder financial exploitation. This talk is sure to hold lessons for practitioners seeking to protect their aging clients from fraud and financial abuse.
